

# School Tree Planting Club Constitution

## Article 1: Name

The name of the club shall be the ..... School Tree Planting Club .....; hereinafter referred to as the .....

## Article 2: Purpose and Objectives

The purpose of the Club is to:

- i. Promote environmental awareness among students.
- ii. Educate members on the importance of indigenous trees.
- iii. Lead tree planting and care initiatives within and around the school.
- iv. Support national and global efforts to combat climate change.
- v. Foster teamwork, leadership, and environmental responsibility.

## Article 3: Membership

- i. All students enrolled at the school who demonstrate a genuine interest in environmental conservation are eligible to become members.
- ii. Members are expected to actively engage in club meetings and participate in scheduled activities.
- iii. The club shall uphold a policy of non-discrimination, ensuring that no individual is excluded or treated unfairly on the basis of age, gender, cultural background, or personal beliefs.

## Article 4: Leadership and Structure

### Club Leadership Structure

The Club shall maintain the following leadership positions, to be filled through annual elections:

- **Chairperson:** Responsible for presiding over meetings and overseeing the coordination of all club activities.
- **Vice-Chairperson:** Supports the Chairperson in their duties and assumes leadership responsibilities in their absence.
- **Secretary:** Maintains accurate records of club proceedings, including meeting minutes and administrative documentation.
- **Treasurer:** Oversees the management of any financial contributions or material resources allocated to the Club.
- **Club Patron:** A designated teacher appointed by the school to provide guidance and mentorship to the Club and its members.

## Article 5: Meetings

- The Club shall convene a minimum of two times per month throughout the academic term.
- Special meetings may be scheduled at the discretion of either the Chairperson or the Club Patron.
- Resolutions and decisions shall be determined by a simple majority vote of the members present.

## Article 6: Activities

The Club may undertake the following activities, among others:

- i. Organizing tree planting events.
- ii. Engaging in the care and maintenance of planted trees.
- iii. Conducting campaigns to promote environmental awareness.
- iv. Hosting competitions and exhibitions related to environmental conservation.
- v. Coordinating nature walks to foster appreciation of natural ecosystems.
- vi. Partnering with local environmental organizations to support shared initiatives.

## Article 7: Amendments

1. This Constitution may be revised through a two-thirds majority vote of the active membership.
2. All proposed amendments must be submitted in writing to the Secretary and formally deliberated during a scheduled meeting.

## Article 8: Dissolution

1. The Club may be dissolved either by directive of the school administration or by unanimous agreement of the Club's leadership.
2. Upon dissolution, all Club assets and official records shall be transferred to the school administration.
